

Spray thoroughly including undersides of foliage. Commence spraying when new shoots sprout in Spring or at first sign of insects or disease. Repeat at 14 day intervals if required.

Two-spotted Mites may require more frequent applications. OR IN ANY MANNER, 10 mL per litre of water
OR
7.5 mL per
750 mL water in a trigger pack NOT TO BE USED FOR ANY PURPOSE, TO THIS LABEL UNLESS AUTHORISED Roses (all types), other Ornamentals (shrubs, flowering annuals & perennials)

USE

HOW TO PREPARE: Shake bottle well. Remove child resistant cap from top of bottle. Measure out required amount and mix in water. Replace child resistant cap.

CAUTION:
DO NOT use on edible crops. DO NOT allow chemical containers or spray to get into drains, sewers, streams or ponds. Keep children and pets away from treated areas until spray has dried.

STORAGE AND DISPOSAL:
